



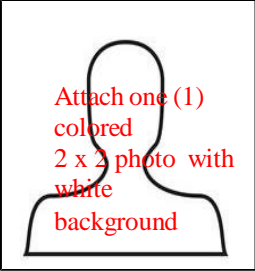

In cases of extensions, applicants with valid accreditation for at least one (1) week, may apply for an extension and only requirements Nos. 1 and 2 shall be submitted to IPC specifying the purpose and scope of the requested extension. Otherwise, such application shall be considered as a new one.

● **ADDITIONAL REQUIREMENTS FOR NEW APPLICANT AND FREELANCER**

- a) 3 to 5 bylined photos/articles (published not later than 3 mos.)
- b) Three (3) consecutive issues of newspaper or magazine (for news publications not later than 3 mos.)
